

# Non-nuclear candidate municipalities in the 1990s

#### Kuhmo

- 12 000 inhabitants
- 5500 km<sup>2</sup>
- Main employer: service businessess, tourism
- Investigation site 30 km from down town

#### Äänekoski

- 14 000 inhabitants
- 1139 km<sup>2</sup>
- Main employer: pulp and paper industry
- Investigation site 25 km from down town

# **Nuclear candidate municipalities in the 1990s**

ÄÄNEKOSKI

Eurajoki

- 6000 inhabitants
- 459 km<sup>2</sup>
- Main employer: Olkiluoto NPP
- Investigation site 14 km from down town

#### Loviisa

- 8 000 inhabitants
- 45 km<sup>2</sup>
- Main employer: service businesses
- Investigation site 14 km from down town







#### Main issues on the local level


- Safety
  - releases from the final repository
  - transportation accidents
  - scientific and technical possibilities to assess the long-term safety

#### Benefits

SAANID & RIEKKOLA

- tax revenues, employment opportunities
- Impact on the *image* of the municipality
  - impact on tourism
  - impact on markets of local agricultural products
  - impact on housing and real estate markets
  - impact on overall quality of life (psychosocial effects)

## Municipalities' (veto right) stance on final disposal

#### Eurajoki

- Most of the people in favor of final disposal
- No opposition movement in the municipality

#### Kuhmo

- Most of the people against final disposal
- Active opposition Romuvaara Movement

#### Loviisa

- Most of the people in favor of final disposal
- Active support for final disposal For Loviisa Movement
- Active opposition Loviisa Movement

#### Äänekoski

SAANID & RIEKKOLA

- Most of the people against final disposal
- Active opposition Kivetty Movement

#### **Notices**

Local opposition movements and NGOs did not do very much cooperation - they had for example their own separate events (Green Peace did not have office in Finland).

Green Peace had one event in Loviisa and one in Eurajoki where the came ashore and had demonstration against disposal project – most of their events has been against nuclear power production.

Also Friends of the earth has campaigned mostly against nuclear power production, not so much against disposal project.

Local opposition movements were active. They had for example their own lecture events and wrote letters to the editor very actively – internet was not used in 1990's.



#### **Local opposition - conclusions**

In the non-nuclear municipalities communication was much more difficult than nuclear municipalities because:

- People did not have any previous experience of nuclear facilities
- People did not trust the safety of geological disposal
- People were afraid of stigmatization
- Situation was regarded unfair: NPP sites and their surrounding areas gained the benefits of nuclear power, whilst the non-nuclear municipalities were to receive the hazardous waste
